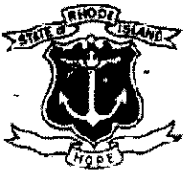

INFORMATION REGARDING THE RENEWAL OF NON-RESIDENT BUSINESS ENTITES

Effective July 1, 2007 R.I. Gen Laws §27-2.4-1 has been amended to eliminate the licensing of insurance business entities. Business entity licenses that are currently in effect will **not** be renewed upon their expiration of May 31, 2008.

Although business entities are no longer required to be licensed individuals who sell, solicit or negotiate must still hold a license. Any producer that does business in any name other than their “legal name” or who conducts business on behalf of a business entity should amend their individual license to include the “assumed name”.
